It is with pride that I address you in my function as Chairman of the tsunami relief initiative INDOGERM.

Only a few days after the tsunami devastated Aceh and Nias, the German and Indonesian private sector decided to jointly pool its resources by founding INDOGERM, the relief initiative of EKONID. With the mission to implement the projects in a transparent and accountable manner in line with BRR reconstruction agency, INDOGERM reached out to thousands of beneficiaries and supported them on their way towards a better future.

Today, almost three years after the founding of INDOGERM, I am pleased to inform you on the many results our initiative has achieved. INDOGERM collected donations amounting to EUR 6.5 Mio. from fifty different companies and individuals. These funds were implemented in almost thirty projects throughout nine districts of Aceh and Nias, across the sectors of education, fishery, child care, health care and community development.

Regular meetings of the INDOGERM Organization Committee and Advisory Board and detailed reports of the project team enabled a comprehensive overview of the developments of INDOGERM at all times.

I would like to thank the donor companies, project staff and EKONID for their trust, commitment and work during the past three years. Their combined efforts made it possible to contribute successfully to the reconstruction and to give new hope to the people of Aceh and Nias.
